

# UH Connect Contest Giveaway Disclaimer

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

## TERMS

**A. ELIGIBILITY:** The Contest is open to legal residents of the fifty (50) United States and the District of Columbia who are adults 18 years of age or older as of November 14, 2018. Employees, agents, officers and directors of the University of Hawai'i Foundation ("UHF") (collectively, the "Contest Entities") are not eligible for the Contest.

**B. ENTRY PERIOD:** The University of Hawai'i Office of Alumni Relations giveaway of one (1) 30,000 HawaiianMiles package, two (2) UH Athletics vouchers and an alumni prize pack (the "Contest") begins at 12:00 a.m. Hawaiian Standard Time on November 14, 2018, and ends at 11:59 p.m. Hawaiian Standard Time on January 7, 2019 ("Contest Entry Period").

**C. HOW TO ENTER:** Each individual who enters earns a chance to win one (1) of three (3) prizes—one (1) 30,000 HawaiianMiles package, two (2) UH Athletics vouchers and an alumni prize pack (the "Prizes"). Enter the Contest during the Contest Entry Period by signing up for UH Connect. To sign up, go to [connect.uhalumni.org](http://connect.uhalumni.org) and click on "JOIN THE COMMUNITY." You will be prompted to create a UH Connect account by signing into your LinkedIn, Facebook, your hawaii.edu account, or by signing-up with an email address. Select your preferred option and follow the prompts. Once you have completed the sign-up process, you are automatically registered for the Contest. To submit more than one (1) entry, invite other UH alumni to sign-up for UH Connect<sup>1</sup>, connect with other alumni on UH Connect<sup>2</sup>, and/or start/participate in discussions on UH Connect<sup>3</sup> ("Contest Entries"). All Contest Entries must be received by 11:59 p.m. Hawaiian Standard Time on January 7, 2019. No purchase of any item or thing of value or the payment of consideration is required to enter.

**D. THE PRIZES:** Contest Entities will award one (1) 30,000 HawaiianMiles package<sup>4</sup>. Contest Entities will also award one (1) set of two (2) UH Athletics vouchers to a 2018-2019 sporting event<sup>5</sup>. Entities will also award one (1) alumni prize pack that includes an assortment of swag items. The Prizes have an approximate retail value ("ARV") of \$889 for the 30,000 HawaiianMiles package, \$40 for the set of two (2) UH Athletics vouchers and \$20 for the alumni prize pack. Certain restrictions may apply to prize(s). There will be no cash compensation.

<sup>4</sup> To claim the 30,000 HawaiianMiles, winners must be members of the HawaiianMiles program. All HawaiianMiles Award Terms and Conditions apply. Additional miles may be required if the award level is not available for the desired flights.

<sup>5</sup> The set of two (2) UH Athletics vouchers to a 2018-2019 sporting event are limited to men's basketball, women's basketball, men's volleyball and baseball. Tickets are based on availability and are limited to UH-sponsored, regular season contests. Tickets are not valid for the Hawaiian Airlines Diamond Head Classic or any post-season contest.

Contest Entities reserves the right in its sole and absolute discretion to award substitute Prizes of equal or greater value if the Prizes described in these Official Rules are unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the prizes represents Contest Entities' good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the Prizes turns out to be less than the stated ARV, the difference will not be awarded in cash. Restrictions, conditions, and limitations may apply. Contest Entities will not replace any lost or stolen prize items.

**E. WINNER SELECTION:** Winner will be selected in a random drawing from among all eligible entries received throughout the Contest Entry Period. The random drawing for the Contest will be conducted in January 2018. The random drawing will be conducted by the University of Hawai'i Foundation Office of Alumni Relations or its designated representatives; all decisions are final. Odds of winning will depend on the number of eligible entries received. Winners will be notified by email within two (2) days of the random drawing. Contest Entities are not responsible, and may disqualify an entrant, if the entrant's email does not work or is changed. Any winner notification not responded to within 30 days or returned as undeliverable may result in a Prize forfeiture and an alternate winner shall be selected. If a potential winner is ineligible to win a Prize because of age or other material misrepresentation, does not comply with the acceptance requirements above or is otherwise in violation of these Official Rules, then such winner will be disqualified and an alternate winner may be selected from the remaining eligible entrants. No substitution or transfer of a prizes is permitted except by Contest Entities.
